**9-7 Approving the Professional Services Agreement Between the Township of Sparta and HPA & Associates, Inc.**

**WHEREAS**, Sparta Township has the need for sewer, water and general engineering services plus an individual to fill the position of Township Engineer for Sparta Township: and

**WHEREAS**, the Township Council desires to contract with Harold E. Pellow & Associates, Inc. to provide sewer, water and general engineering services and Cory L. Stoner, P.E. as the Township Engineer: and

**WHEREAS**, the compensation for professional services to be rendered may exceed the maximum permissible amounts specified in the Public Contracts Law. However, the services constitute "professional services" and are exempt from public bidding pursuant to N.J.S.A. 40A:11-5(10)(a) of the Public Contracts Law because the services are rendered or performed by a person authorized by law to practice a recognized profession, rendered or





performed by a person whose practice is regulated by law, and/or the performance thereof requires knowledge of an advanced type in the field of learning required by a prolonged formal course of specialized instruction and study as distinguished from general academic training, instruction or apprenticeship; and

#### **9-11 A Resolution of the Township of Sparta, County of Sussex, New Jersey Supporting RevolutionNJ**

**WHEREAS**, Governor Philip Murphy and the New Jersey State Legislature created RevolutionNJ in 2018 to plan, encourage, develop, and coordinate the commemoration of the 250<sup>th</sup> anniversary of the founding of the United States, New Jersey's pivotal role in the American Revolution, and the contributions of its diverse peoples to the nation's past, present, and future; and

**WHEREAS**, the New Jersey Historical Commission, under the leadership of Secretary of State Tahesha Way, with its non-profit partner Crossroads of the American Revolution established RevolutionNJ to advance the role that history plays in public discourse, community engagement, education, tourism, and scholarship in New Jersey; and

**WHEREAS**, RevolutionNJ will engage New Jerseyans in all 21 counties and 564 municipalities through its officially recognized programs, initiatives, and events over the next ten years; and

**WHEREAS**, it is fitting and desirable that we commemorate the beginning of the Nation and the role New Jersey played over the past 250 years as well as its present and future role as part of the United States, with particular focus on the individuals, ideas, and events that shaped our Country, State, and [County/City/Borough/Township]; and



**WHEREAS**, RevolutionNJ will consider the role New Jersey played during the American Revolution when it saw more battles and skirmishes than any other state and was truly the Crossroads of the American Revolution; and

**WHEREAS**, RevolutionNJ will highlight the role New Jerseyans played beyond the battlefield during the American Revolution when people of diverse backgrounds contributed to the development of the State and the Nation in various ways and fought for the right to life, liberty, and the pursuit of happiness; and

**WHEREAS**, preserving, studying, and enjoying state history strengthens communities and builds bonds between New Jersey residents as we work together toward the goals of justice and equality embedded in the United States Constitution;

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Council of the Township of Sparta hereby endorses RevolutionNJ and its mission to advance the role that history plays in public discourse, community engagement, education, tourism and scholarship in New Jersey.

**IT IS FURTHER RESOLVED** that:

1. The Sparta Township Council commemorates the 250th anniversary of the establishment of the United States as an independent Nation.
2. The Sparta Township Council authorizes the appointment of a committee to develop a plan for this commemoration that will promote the maximum involvement of our residents, neighborhoods, businesses, schools, civic organizations, and institutions in the commemorations.
3. The Sparta Township Council further urges all its residents to reflect upon the significance of this event and the role that our State and its diverse people have played in the history and development of our Nation and to participate in this important commemoration, endeavoring to include the stories of all those whose lives are part of the history of what we now know as New Jersey, and understanding that the revolution continues today as we uphold the revolutionary ideals articulated in our founding documents.

**9-12 Resolution Establishing A Business Development Committee**



**WHEREAS**, the Sparta Township Council has determined that input from those most knowledgeable of the intricacies of business and economic trends should be considered by the Township Council.

**WHEREAS**, the Sparta Township Council deems it appropriate to establish a committee to study, prepare reports and advise the Council on the development of business in the Township of Sparta; and

**NOW, THEREFORE, BE IT RESOLVED** by the Sparta Township Council, County of Sussex and State of New Jersey, that Resolution 5-5 (2006) is hereby repealed in its entirety and that the Economic Development Advisory Committee is hereby dissolved.

**BE IT FURTHER RESOLVED** that a Business Development Committee is hereby established.

**BE IT FURTHER RESOLVED** that the Business Development Committee shall be advisory in nature only and have the following structure, goals, and objectives:

- 1) The Committee shall be known as the “Business Development Committee.”
- 2) The Committee’s charter and activities shall align with the vision and objectives of the Sparta Township Master Plan.
- 3) The Business Development Committee shall consist of seven (7) members, as follows:
  - a. Four members who are business owners in Sparta, to be appointed by the Council;
  - b. Two Sparta residents who are not business owners, to be appointed by the Council;
  - c. One current member of the Sparta Township Chamber of Commerce to act as liaison, to be recommended by the President of the Sparta Township Chamber of Commerce and appointed by the Council;
  - d. The Committee Chairperson shall be selected by the members of the Committee from the Committee members; and
  - e. Committee Members shall serve for one year, with each term expiring on December 31 of the calendar year of their appointment.



- 4) The Committee shall have three non-voting Liaison Members, appointed by the Council, who shall serve for one year with each term expiring on December 31 of the calendar year of their appointment, with one Liaison Member from each of the following:
  - a. Township Council;
  - b. Planning Board;
  - c. Zoning Board.
  
- 5) The Scope of the Committee is as follows:
  - a. The Committee is advisory in nature only, and shall provide advice to the Council and Planning Board. No action taken by the Committee shall affect any ordinance, administrative function, or administrative practice;
  - b. The Committee shall solicit, formulate, and propose policy and administrative changes to support the growth and well-being of existing and new business in Sparta Township;
  - c. The Committee shall partner with the Sparta Township Chamber of Commerce to solicit policy and administrative changes suggested by that organization; and
  - d. The Committee is empowered to perform its own studies in order to craft or support its proposed policy and administrative changes.
  
- 6) The Committee shall operate as follows:
  - a. The Committee shall produce a written report to the Council and Planning Board once a year summarizing the policy and administrative changes recommended by the Committee;
  - b. The Committee shall keep and make available to the public minutes from its meetings.

If any section, subsection, sentence, clause or phrase in this resolution is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining parts of this resolution.



**9-13 Resolution of the Township of Sparta in Support of the Continued Enjoyment of the State's Waters for Drinking Water and Recreation Without Harm to Agriculture**

**WHEREAS**, Sparta Township has approximately 19,722 residents, most of whom receive drinking water from underground aquifers; and

**WHEREAS**, Sparta Township contains approximately 95.45\* linear miles of streams, tributaries, and rivers, in addition to Lake Mohawk, Saginaw Lake, Lake Grinnell, Sparta Lake, Fox Hollow Lake, Upper Lake Mohawk and many other waters, which may be used for recreation, drinking water, agriculture, fish and wildlife habitat, and other purposes; and

**WHEREAS**, significant investments have been made for the acquisition of land for the public use and enjoyment, especially land with surface waters, through use of public funds by Sparta Township and governmental and non-governmental agencies; and

**WHEREAS**, clean water from streams, rivers, lakes, and other surface waters contribute to the municipality's scenic and aesthetic qualities, real estate and home values, and economic opportunities from recreation and tourism; and

**WHEREAS**, the loss of good water quality in streams, rivers, lakes, and other surface waters can result in a loss of the municipality's scenic and aesthetic qualities, real estate and home values, and economic opportunities from recreation and tourism; and

**WHEREAS**, recreational uses have not been incorporated by the N.J. Department of Environmental Protection into assessments for developing anti-degradation safeguards for discharges to surface waters; and

**WHEREAS**, the waters in streams and rivers are held in the public trust and recreation may occur on those waters, but the land underlying them may be owned privately or publicly, and trespass on private lands is prohibited; and

**WHEREAS**, agriculture is an important activity, and no additional restriction or undue burden should be placed on agriculture with regard to water withdrawals, which are already regulated by the Water Supply Management Act, and

**WHEREAS**, municipal residents rely on underground aquifers as their drinking water





source; and

**WHEREAS**, underground aquifers can include porous rock formations, vulnerable to the mixing of contaminated surface and ground waters, such as carbonate bedrock; and

**WHEREAS**, the presence of pollutants in a surface water or groundwater may inadvertently put drinking water aquifers at risk; and

**WHEREAS**, the additional costs associated with the treatment of degraded drinking water supplies can be a burden to homeowners, industry, and drinking water suppliers; and

**NOW, BE IT RESOLVED**, that Sparta Township encourages:

- 1) The Department of Environmental Protection to develop methods for identifying waters already utilized for recreational purposes to ensure water quality in these areas are not degraded by new discharges; and
- 2) The Department of Environmental Protection to promote the protection of drinking water aquifers, including waters in carbonate rock areas; and
- 3) The Department of Environmental Protection to establish anti-degradation standards for small public water supply systems and waters in the Highlands Region to protect drinking water quality; and
- 4) The Department of Environmental Protection to preserve and enhance water quality by protecting headwater streams from disturbances; and
- 5) That any actions the Department of Environmental Protection may take in response to this resolution, be done so in consultation with the stakeholders, including municipalities; and
- 6) That the state should provide adequate resources to ensure the public's access to state lands and waters.

A copy of the Resolution shall be place on file with the Clerk of the Township.

Copies of this Resolution shall be sent to Sparta Township's Representatives in the New Jersey Legislature, and a copy shall be sent to the Governor of the State of New Jersey.

**WHEREAS**, the Sparta Township Council desires to amend Article III, Section 2-3.2 of the Township of Sparta Municipal Code; and

**WHEREAS**, the Sparta Township Council has approved a change to the time the Township Council Meetings for its Council Meetings, on the second and fourth Tuesdays of each month, from 7:30 p.m. to 7:00 p.m.

**NOW, THEREFORE, BE IT ORDAINED** by the Sparta Township Council, in the County of Sussex, State of New Jersey, that the Municipal Code of the Township of Sparta, Article III, Meetings of Township Council, Section 2-3.2, Regular Meetings, as follows:

**Section 1.** Section 2-3.2 is amended as follows:

The Council shall meet regularly in the Municipal Building or such other public building as may be determined by Resolution, on the second and fourth Tuesdays of each month at 7:00 p.m. prevailing time, except that the Council may, by Resolution, dispense with one or more of the regular meetings otherwise scheduled. When the time for any regular meeting of the Council shall fall on a holiday, the meeting shall be held at the same hour on the next succeeding day which is not a holiday.

**Section 2.** Severability. If any provision of this ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3.** Repealer. All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this ordinance are hereby repealed in their entirety.

**Section 4.** Effective Date. This ordinance shall take affect after final passage and publication as required by law.
