

**AN ORDINANCE OF THE TOWNSHIP OF SPARTA AMENDING CHAPTER 8 OF  
THE TOWNSHIP CODE ENTITLED, “FILMING” TO ESTABLISH A FILM  
COMMITTEE**

**Purpose:**

To establish a Sparta Film Committee to attract and encourage film and other entertainment production in Sparta Township because such production benefits local businesses and provides funds to Sparta Township through application fees and other monies necessary to offset any costs incurred by Sparta Township for hosting film and entertainment production.

**WHEREAS**, the Township of Sparta desires to amend Chapter 8 of the Township Code entitled “Filming” to establish a Sparta Township Film Committee; and

**NOW THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Sparta, County of Sussex, State of New Jersey, that the Sparta Township Municipal Code is amended as follows:

CHAPTER 8, “**FILMING**” is amended as follows:

**SECTION 1**

A new Section 8-13 entitled “**Establishment of Sparta Township Film Committee**” is created according to the following requirements.

**Section 8-13.1 Creation.**

The Sparta Township Film Committee is hereby created. All references to Sparta Township Film Readiness Committee within this Chapter is replaced with “Sparta Township Film Committee.”

**Section 8-13.2 Appointment, Composition and Term of Committee Members.**

The Sparta Township Film Committee shall consist of:

(a) three voting members to include Chairperson, First Assistant Chair, and Second Assistant Chair, each of whom shall be appointed by the Township Council and have a term of three years until appointment and qualification of their successors;

(b) four non-voting members to include a Township Council Liaison, Chief Creative Ambassador, Chief Administrator, and Communications Coordinator, each of whom shall be appointed by the Township Council and have a term of three years until appointment and qualification of their successors, except that the Council Liaison shall have a term of one year and be appointed annually;

(c) seven non-voting general committee members, each of whom shall be appointed by the Township Council and have a term of three years until appointment and qualification of their successors.

**SECTION 2** If any section, sub-section, paragraph, sentence or any other part of this ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this ordinance.

**SECTION 3** All ordinances or parts of ordinances that are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4** This ordinance shall take effect 20 days after final passage and publication as prescribed by law.
