

AN ORDINANCE OF THE TOWNSHIP OF SPARTA SETTING THE 2019 UTILITY  
CAPITAL CONNECTION FEES

**WHEREAS**, the Sparta Township Sewer and Sewage Disposal Ordinance, Chapter XX, Sections 20-3.6(d)&(e) requires the payment of connection fees for properties that connect to the Township 's sewer systems; and,

**WHEREAS**, the Township Engineer and the Utility Director have reviewed the fees and recommended that the fees for the year 2019 be amended as provided for in this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the Sparta Township Council, County of Sussex, State of New Jersey, that the Utility Capital Connection Fees as provided for in Township Ordinance Sections 20-3.6(d)&(e) and Appendix A-20.4 are set for the year 2019 as follows:

	Cost Per EDU*
Town Center Sanitary Sewer Collection System Sparta Local Connection Fee	\$6,780
White Deer Plaza Treatment Municipal Utility Connection Fee	\$13,394
Sparta Township Water Utility Capital Connection Fee	\$8,436

\*EDU = Equivalent Dwelling Unit = 250 gpd

**Section 1. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 2. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.

**Section 3. Effective Date.** This ordinance shall take effect after publication and passage according to law.
