

**AN ORDINANCE AMENDING ARTICLE III, MEETINGS OF TOWNSHIP COUNCIL,  
SECTION 2-3.2, REGULAR MEETINGS OF THE MUNICIPAL CODE OF THE  
TOWNSHIP OF SPARTA**

**WHEREAS**, the Sparta Township Council desires to amend Article III, Section 2-3.2 of the Township of Sparta Municipal Code; and

**WHEREAS**, the Sparta Township Council desires a change to the time the Township Council Meetings are to commence on the second and fourth Tuesdays of each month, from 8:00 p.m. to 7:00 p.m.

**NOW, THEREFORE, BE IT ORDAINED** by the Sparta Township Council, in the County of Sussex, State of New Jersey, that the Municipal Code of the Township of Sparta, Article III, Meetings of Township Council, Section 2-3.2, Regular Meetings, as follows:

**Section 1.** Section 2-3.2 is amended as follows:

The Council shall meet regularly in the Municipal Building or such other public building as may be determined by Resolution, on the second and fourth Tuesdays of each month at 7:00 p.m. prevailing time, except that the Council may, by Resolution, dispense with one or more of the regular meetings otherwise scheduled. When the time for any regular meeting of the Council shall fall on a holiday, the meeting shall be held at the same hour on the next succeeding day which is not a holiday, or as otherwise determined by the Council.

**Section 2.** **Severability.** If any provision of this ordinance or the application of this Ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.

**Section 3.** **Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this ordinance are hereby repealed in their entirety.

**Section 4.** **Effective Date.** This ordinance shall take affect after final passage and publication as required by law.
